

Panelist: Karen Freeman-Wilson, Charter | Harvard College
Karen Freeman-Wilson is the President and CEO of the Chicago Urban League in January
2020. Freeman-Wilson has vast experience in addressing issues that impact urban
communities. She was Mayor of her hometown of Gary, Indiana, from 2012 through 2019.
She was the first female to lead the city of Gary and the first Black female mayor in Indiana.

Freeman-Wilson previously served as Indiana Attorney General, Director of the Indiana Civil Rights Commission, and presiding judge of the Gary City Court. She also served as Executive Director of the National Drug Court Institute and CEO of the All Rise (previously the National Association of Drug Court Professionals), where she is immediate past Board Chair.



Panelist: Danté Anderson, SP94 | Massachusetts Institute of Technology
Danté Anderson is an experienced senior business executive and a native of Charlotte,
North Carolina. She has over 25 years of work experience in corporate America at Fortune
500 global companies managing billion-dollar budgets. Most recently, she was the Chief
Business Officer of the Information Technology division of Cisco Systems.

Danté has been a member of several boards of directors and advisory boards including Blumenthal Arts, the Walton Arts Center, Susan G. Komen and Ren West Community Initiative. She holds an MBA from the Harvard Business School, an MFA from The Tisch School at New York University and a bachelor's of Science from Massachusetts Institute of Technology. Danté has traveled to 53 countries and 45 United States.

Danté currently represents District 1 on Charlotte City Council and serves as Mayor Pro Tem.

Panelist: Liz Miranda, SP01 | Wellesley College

Massachusetts State Senator Liz Miranda is beginning her second term serving the Second Suffolk District, representing nine neighborhoods in Boston. She also served as a Massachusetts State Representative representing the 5th Suffolk District from 2019-2022. Most recently, her Maternal Health Omnibus Bill and Liquor License Bill for the City of Boston were both signed into Law by Governor Maura Healey. Miranda was also named Bostonian of the Year by The Boston Globe in 2024 for her work providing 225 new wealth generative Liquor Licenses for Boston's neighborhoods.

As the Senate Chair of the Racial Equity, Civil Rights and Inclusion Committee, Vice Chair of the Children, Families & Persons with Disabilities Committee, and is also proud to serve on Committees related to Ways & Means, the Census, Juvenile & Emerging Adult Justice, Economic Development & Emerging Technologies & the Judiciary. Senator Miranda has focused on equity and justice in all of her legislative and budget priorities. Senator Miranda is a member of the National Caucus of Black State Legislators and the Eastern Regional Representative in NOBEL, the National Organization of Black Elected Legislative Women. Senator Miranda also served as Wellesley College's 143rd Commencement Speaker for the Class of 2021.



Panelist: Shayla Adams-Stafford, SP07 | Wellesley College

Shayla Adams-Stafford is the CEO and Founder of AdaptiveX, a professional development and software company dedicated to advancing culturally responsive teaching and learning through the lens of racial equity. AdaptiveX works with educators and school leaders in over 20 school districts nationwide, establishing itself as a leader in promoting assessment equity. Shayla's innovative approach empowers K-12 teachers with adaptive testing tools, helping them better meet the diverse needs of their students. Her groundbreaking work has earned recognition in national pitch and hackathon competitions and led to AdaptiveX being featured on Nasdaq Trade Talks after Shayla became a finalist in the International Penn Milken Business Plan Competition.

In 2020, Shayla ran for public office and won a seat on the Prince George's Board of Education- one of the largest school systems in America serving over 130,000 Students. During her time in office, Shayla led the initiative for Equity Learning Hubs, revitalized the Parent and Community Advisory Council, and passed the Bridge to Excellence Schools budget amendment, which allocated \$10M for underperforming schools within the district. Shayla helped to build 14 schools and allocate millions in mental health funding to schools during the pandemic. She won the Democratic primary for the Prince George's County Council District 5 seat on March 4, 2025, securing 46.71% of the vote in a 6-way race.
